

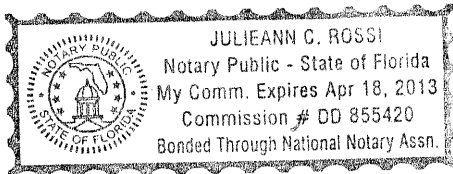

The City of Oakland Park hereby invites qualified Contractors to submit sealed Bids for performance of the Work of this Project. Bids will be received by the City Clerk's Office, City of Oakland Park, 3650 N.E. 12th Avenue, Oakland Park, Florida 33334, until 2:30 PM, Tuesday July 6th, 2010 and will then be transferred to the City Commission Chambers where Bids will be opened and read aloud for:

Project Name: Sleepy River North Maintenance Dredging Project
This Project is located within the corporate limits of the City of Oakland Park, in Broward County, Florida. The Project begins at the Northwest corner of the intersection of Andrews Avenue and Oakland Park Boulevard and extends northwest to Powerline Road. This Project proposes the maintenance dredging of portions of the Sleepy River from Oakland Park Boulevard to Powerline Road through the Lloyd Estates Residential Neighborhood. The bidder (prime contractor) must perform, on the site and with his own organization, work equivalent to at least 51% of the Contract price. Bidding contractors are to provide references and a brief narrative describing similar projects completed by their firm. Similar project(s) are considered to be dredging projects that involved hand held hydraulic dredging in environmentally sensitive areas.

All materials furnished and all work performed shall be in accordance with the Contract Documents pertaining thereto, including Drawings and Specifications, which may be examined at or obtained at the offices of:

Bids must be submitted on the Bid Form as furnished by the City of Oakland Park and must be accompanied by a bid security in the form of a Bid Bond, Certified Check, Cashier's Check, Treasurer's Check or Bank Draft, or other form of security acceptable to the City in a sum not less than five percent (5%) of the amount of the base bid, as a guarantee that the bidder will enter into an agreement with the City if the bid is accepted. Bids shall remain in force for ninety (90) days after the time of opening.

The City reserves the right to reject any and all bids and to waive informalities in any bid whenever such action is in the interest of the City.

There will be a MANDATORY pre-bid conference at 10:00 AM on Monday June 28th 2010 at the City Hall, City Commission Chambers, 3650 N.E. 12th Avenue, Oakland Park. Failure to attend may result in disqualification for non-responsiveness at the discretion of the City.
